THE SHELTER OPERATES A CONFIDENTIAL 24 HOUR HOTLINE. THIS PROGRAM ALSO OFFERS DOMESTIC VIOLENCE OR SEXUAL ASSAULT OR ABUSE LEGAL ADVOCACY AND SUPPORT TO INDIVIDUALS SEEKING LEGAL REMEDY IN THE CIVIL AND CRIMINAL JUSTICE SYSTEMS. DURING 2022, THE SHELTER PROVIDED 6,480 NIGHTS OF CARE TO 137 ADULTS AND CHILDREN AND TOOK 6,775 HOTLINE CALLS. THE SHELTER ALSO RECEIVED 679 CLIENT REFERRALS FROM LAW ENFORCEMENT, INCLUDING 267 FACING A HIGH RISK OF HOMICIDE AS DETERMINED THE LETHALITY ASSESSMENT PROGRAM.
